- a. To act as a nodal agency for the management of the implementation of financial management systems and related services for the Finance Department, HoDs and related line departments / organizations of the Government.
- b. To act as a nodal agency to take ownership of selection of suitable and qualified service providers, managing the service providers and to ensure that the highest standards are being adopted for the implementation and the service providers are adequately staffed and facilitated in achieving the goals.
- c. To support the legacy systems and work for the smooth transition to a newer system.
- d. To provide oversight and IT management for the financial management systems in the Finance Department, HODs under finance department and line departments with budgets and controls

- 2. Staffing pattern of APCFSS is based on effective deputations from various Government Secretariat departments and Heads of the Departments. The deputed resources are expected to work full-time at APCFSS and provide services towards accomplishing the objectives of the Centre.
- 3. Towards this, nominations were received from Finance Department and the HODs under the administrative control of the Finance Department vide references cited at 2<sup>nd</sup> through 5<sup>th</sup> above.
- 4. Government, after careful examination of the matter hereby accords permission for the following staff members from the Finance Department and Heads of the Departments to be deputed to Andhra Pradesh Centre for Financial Systems and Services (APCFSS) for a period of 2 years with immediate effect, to work as Functional Experts/Business Analysts on usual terms and conditions as stipulated in G.O(P) No.10, dt.22.01.1993 of Fin.(FR.II) Department and orders issued from time to time by the Government.
